Terms and Conditions

The Terms and Conditions hereunder, together with the Policies and Procedures and the Compensation Plan set forth in the Independent Business Owner starter kit and at any particular date as then shown on www.ourworldnetwork.com website, form the agreement (the "Agreement") between the Independent Business Owner IBO, ("Distributor") and OWN, Our World Network Inc. ("Company"). Upon acceptance by OWN of the Distributor Registration and Agreement Form at its Corporate Office, the applicant is appointed an Independent Business Owner (IBO) for OWN. The Independent Business Owner (IBO) confirms, understands and agrees:

1. The IBO is hereby appointed on the Terms and Conditions herein contained and on the terms of the Compensation Plan, Policies and Procedures, and any other literature that may be issued or modified from time to time. The IBO agrees to observe and be bound by these Terms and Conditions and to abide by any modifications to the Policies and Procedures or Compensation Plan reasonably implemented by the Company and notification given to the IBO.
2. The IBO acknowledges that to become an OWN IBO there is no inventory purchase required. Only an Annual Membership Fee is required to cover administration expenses including your OWN replicated website. This Annual Membership Fee is non-refundable.
3. The term of this Agreement shall be for one (1) year from the month of acceptance by the Company, unless earlier terminated by the Company. Provided the IBO does not breach any of the Terms and Conditions of this Agreement, this Agreement may be renewed by the IBO for successive terms of one (1) year. The IBO must apply to renew and submit payment of the Annual Renewal Membership Fee in accordance with the then existing Policies and Procedures of the Company in the anniversary month of this Agreement.
4. The IBO confirms and acknowledges that the IBO is wholly an "Independent Contractor" who establishes and services retail customers for the Company's products and is not an employee of OWN. The position of "Independent Business Owner" does not constitute either the sale of a franchise or a distributorship. This Agreement is not intended and shall not be construed to create a relationship of employer/employee, agency, partnership or joint venture between any Independent Business Owner and the Company.

As an independent contractor, the IBO shall:
 - a) Place the primary emphasis in promoting on the retail sale of the Company's products.
 - b) Abide by any and all federal, provincial, state and local laws, rules and regulations pertaining to this Agreement and the acquisition, receipt, storing, selling, distribution or advertising of the Company's products.
 - c) At the IBO's own expense, make, execute or file such reports and obtain such licenses as are required by law or public authority with respect to this Agreement and/or the receipt, storing, selling, distributing or advertising of the Company's product or services.
 - d) Be solely responsible for the declaration and payment of all local, provincial, state and federal taxes that may accrue and are payable because of the IBO's activities or income in connection with this Agreement.
 - e) Not make any statements or representations regarding the Company's products or Compensation Plan other than those contained in materials provided by the Company.
5. An IBO may return merchandise and sales aid/literature items purchased directly from the Company in their original condition shipping prepaid to the Head Office for refund within the first 30 days of the purchase period for a full refund less 10% restocking charge and any shipping and handling. Any commission already paid to the IBO on returned inventory, together with the value of any promotional prizes won by the IBO will be deducted from the refund amount which shall be paid within fourteen (14) days.
6. The Company may suspend or terminate this Agreement immediately in the event the IBO breaches any covenant contained herein or in the Policies and Procedures.

An IBO shall be entitled to cancel their Distributorship at any time and for any reason upon sending written notarized notice to the Company and the sponsoring IBO.

7. The IBO shall have the right to sell the products offered by the Company in accordance with the Company's Policies and Procedures and Compensation Plan. Any IBO who sponsors other IBOs must fulfill the obligation of performing bona fide supervision, in the sale of the product to the consumer and in the training of those sponsored. An IBO must have on-going contact, communication and management supervision with his or her sales organization on a monthly basis.
8. The IBO acknowledges that this Agreement shall not become binding on either party until it has been accepted by the Company at its home office and shall be governed by the laws of the province of British Columbia, Canada. In the event that a dispute arises between the Company and an IBO or among IBOs as to their respective rights, duties and obligations under this Agreement, such disputes shall be exclusively resolved pursuant to the Appeal procedure in the Policies and Procedures manual.
9. It is expressly agreed by the Distributor that there are no verbal or written representations, understandings, stipulations, agreements or promises relating to the subject matter of the Agreement not incorporated in writing in this Agreement and that this Agreement constitutes the entire agreement between the parties, unless such agreements are acknowledged in writing by the company.
10. The IBO agrees not to utilize OWN logos, trade names, marketing materials, product names or trademarks or those of its products in any way other than those permitted expressly in writing by the Company or in the Policies and Procedures. The IBO agrees to utilize only those items of literature and sales aids provided by the Company. The Independent Business Owner shall not name OWN executives, employees, endorsement personalities or affiliates in any advertising format or medium without the express written consent of OWN.
11. The Terms and Conditions of this Agreement shall be binding upon and enforceable by the heirs, executors, administrators and transferees of the parties hereto. The IBO understands that the Distributorship position can be inherited or bequeathed, but cannot be transferred or assigned during the lifetime of the IBO without the written consent of the Company, which consent shall not be unreasonably withheld.
12. The IBO understands the Company does not discriminate in its acceptance or rejection of applicants because of race, creed, gender, national origin, religion or sexual orientation.
13. If any provision of the Agreement is found to be invalid all other provisions and clauses shall remain in full force and effect.
14. Failure to comply with any provision of the Agreement may result in the suspension or termination of the Distributorship.
